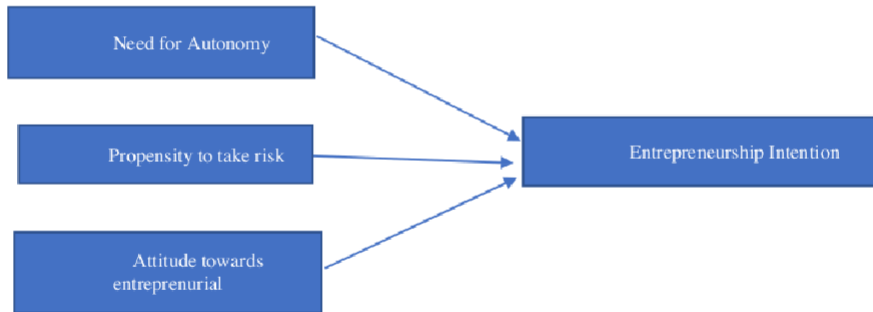


Fig. 1 Frame Work of the Study
