# CONFERENCE PROCEEDINGS FORMATTING GUIDELINES TITLE SHOULD BE CENTRED, BOLDED, FONT SIZE 14, TIMES NEW ROMAN, FULLY CAPITALIZED First Author<sup>1\*</sup>, Second Author<sup>2</sup> and Third Author<sup>3</sup>

*Abstract*—These instructions give you guidelines for preparing papers for conferences or journals. Use this document as a template if you are using Microsoft Word. Otherwise, use this document as an instruction set. All articles must contain an abstract. The abstract text should be formatted using 10 point Times New Roman. The abstract should give readers concise information about the content of the article, research background, methods and indicate the main results obtained and conclusions drawn. The abstract is not part of the text and should be complete in itself; no table numbers, figure numbers, references or displayed mathematical expressions should be included. It should be suitable for direct inclusion in abstracting services and should not normally exceed 300 words in a single paragraph.

Keywords—About 3-5 key words or phrases in alphabetical order, separated by commas.

## **INDTRODUCTION**

The introduction section should be written in a way that is accessible to researchers without specialist knowledge in that area. Introduction should contain background and research objective. The section should be end with a brief statement of what is being reported in the article.

# MATERIALS AND METHODS (Heading 1)

#### Writing The Materials and Methods (Heading 2)

The materials and methods section should include the design of the study, the type of materials involved, a clear description of all comparisons, and the type of analysis used, to enable replication. For studies involving human participants a statement detailing ethical approval and consent should be included in the methods section.

#### **RESULTS AND DISCUSSION**

#### Selecting a Template

First, confirm that you have the correct template for your paper size. This template has been tailored for output on the A4 paper size (21cm x 29.7 cm). Margins on all four sides are 2 cm. Do not number your pages. The body of the paper should be set to one column. Please use 11 point Times New Roman throughout your document (except title and abstract), including author name (bold) and author information. The body text should be fully justified. All headings should be in 11 point Times New Roman and bolded, heading (1) must be FULLY CAPITALIZED. Headings may be fully or left-justified; please choose one style and use it throughout your paper. Also, ensure that the spacing between headings and text are consistent.

Please name this paper with your CODE-NUMBER and save this paper as a "Word 97-2003 Document" for the PC, provides authors with most of the formatting specifications needed for preparing electronic versions of their papers. All standard paper components have been specified for three reasons: (1) ease of use when formatting individual papers, (2) automatic compliance to electronic requirements that facilitate the concurrent or later production of electronic products, and (3) conformity of style throughout a conference proceeding.

#### Equations

The equations are an exception to the prescribed specifications of this template. You will need to determine whether or not your equation should be typed using either the 11 point Times New Roman or the

Symbol font (please no other font). To create multileveled equations, it may be necessary to treat the equation as a graphic and insert it into the text after your paper is styled.

Number equations consecutively. Equation numbers, within parentheses, are to position flush right, as in (1), using a right tab stop. To make your equations more compact, you may use the solidus (/), the exp function, or appropriate exponents. Italicize Roman symbols for quantities and variables, but not Greek symbols. Use a long dash rather than a hyphen for a minus sign. Punctuate equations with commas or periods when they are part of a sentence, as in:

$$a+b=\gamma\tag{1}$$

Note that the equation is centered using a center tab stop. Be sure that the symbols in your equation have been defined before or immediately following the equation. Use "(1)", not "Eq. (1)" or "equation (1)", except at the beginning of a sentence: "Equation (1) is ..."

#### **Figures and Tables**




Figure 1 Place each figure and graph in a document as close as possible to its first mention in the text, graph should not contain gridlines, figure and graph should not contain border

All figures and tables should be centered and numbered consecutively (see Figure 1 and Table 1). All figures and tables should be embedded in text, not as an attachment after References Section. Figure captions should be below the figures; table heads should appear above the tables. Insert figures and tables after they are cited in the text. Please verify that the figures and tables you mention in the text actually exist. Use 9 point Times New Roman for Figure text and labels. Use words rather than symbols or abbreviations when writing Figure axis labels to avoid confusing the reader.

The section should clearly state the main conclusions of the research and provide a clear explanation of their importance and relevance. This section should not contain discussion anymore. Please write the conclusions as a paragraph, not per point.

#### ACKNOWLEDGEMENTS

Please acknowledge anyone who contributed towards the article by making substantial contributions to conception, design, acquisition of data, or analysis and interpretation of data, or who was involved in drafting the manuscript or revising it critically for important intellectual content, but who does not meet the criteria for authorship. Please also include the source of funding for each author, and for the manuscript preparation. Authors must describe the role of the funding body, if any, in design, in the collection, analysis and interpretation of data; in the writing of the manuscript; and in the decision to submit the manuscript for publication. Please also acknowledge anyone who contributed materials essential for the study.

## REFERENCES

Number citations consecutively in square brackets [1]. The sentence punctuation follows the brackets [2]. Multiple references [2], [3] are each numbered with separate brackets [1]–[3]. When citing a section in a book, please give the relevant page numbers [2]. In sentences, refer simply to the reference number, as in [3]. Do not use "Ref. [3]" or "reference [3]" except at the beginning of a sentence: "Reference [3] shows ...." Check that references are fully justified, not left-justified.
